You have been awarded student financial aid from the state of Washington. A state grant recipient has the following two choices:

WASHINGTON GRANT PROGRAMS

CONDITIONS OF AWARD

You are being considered for a grant from the State of Washington. If you receive this grant there are seven special conditions, listed below, with which you must comply. If you have questions or find that you cannot comply with these conditions please see the financial aid office at Whitworth University.

1. You do not owe a refund or repayment on a State Grant, a Pell Grant, or a Supplemental Education Opportunity Grant, nor are you in default on a loan made, insured, or guaranteed under the Perkins, National Direct, or Federal Family Education Loan programs. In addition, you are not in default on a loan made through a state conditional loan or conditional scholarship program.
2. This grant is awarded to assist in meeting your educational expenses; and should you withdraw from classes, repayment of all or a part of the grant may be required.
3. You can choose to voluntarily make financial contributions to the Higher Education Coordinating Board in recognition of this State Grant. All voluntary contributions will be used to provide financial assistance to other students.
4. The offer of a State Grant is subject to and conditioned upon the availability of funds. The Higher Education Coordinating Board and Whitworth University through which the grant is awarded, reserve the right to withdraw, reduce, or modify the grant due to funding limitations or due to changes in circumstances which affect your eligibility for the state grant.
5. You are not pursuing a degree in theology.
6. You must finish at least 50% of your attempted credits each semester to qualify for the state funds the next semester.
7. You have been a resident of the State of Washington for a year or more as defined by RCW 28B.15.011-RCW 28B.15.015 and plan to continue to be a resident of the State of Washington.
