

**INFORMATION YOU SHOULD KNOW IF YOU WITHDRAW BEFORE FINISHING THE SEMESTER...**

- If you have received loans while you attended Whitworth University, you are required to obtain **loan exit counseling** (per federal law), which will give you further information on your loan(s). Federal Direct Loan exit counseling information can be found at <https://studentaid.gov>. Loan repayment will begin at the end of your grace period of six months except in the case of the Perkins Loan and Institutional Loan which both have a nine-month grace period. Perkins Loan counseling is handled through the Perkins Loan Office on campus.
- If you have an **award for next semester, it will be cancelled.**
- Withdrawing may affect your academic progress. Students are granted one warning semester to improve their progress. If after the warning semester it is found that you are not maintaining **satisfactory academic progress, you will need to write an appeal** and have it approved in order to receive aid again from Whitworth University in the future. - The **date of your withdrawal will be based on the day that you return a completed withdrawal form to the Registrar's Office** at Whitworth University. Students who unofficially withdraw from classes and/or the university (that is simply cease to attend classes without notifying the university) will be considered to have withdrawn when 50% of the semester has passed for federal and state aid and are not eligible for a Whitworth University refund.
- The **Student Accounting Services Office will determine your eligibility for a refund of charges** for the semester based on when you have withdrawn. Whitworth's refund schedule is available on the Student Accounting Services website. For students enrolled in a standard 15 week semester the refund schedule is:

<u>Withdrawal/Drop During</u>	<u>Refund</u>	<u>Applicable to</u>
First & Second Week	100%	Tuition, Room, Board and Fees
Third Week	75%	Tuition, Room, Board, no Fees
Fourth Week	50%	Tuition, Room, Board, no Fees
Fifth Week	25%	Tuition, Room, Board, no Fees
Sixth Week	0%	Tuition, Room, Board, no Fees

- According to federal regulations, **federal funds must be returned to federal programs** based on the percent of the term that a student is no longer enrolled. The Financial Aid Office will determine how much of a student's federal aid was "unearned" as defined by the federal regulations, and then return the unearned aid.

Unearned aid will be returned in the following order to the programs from which the student received aid:

- Whitworth University will **return Whitworth University sponsored aid to its source**, based on the refund that the Student Accounting Services Office determines. If a student will be refunded 75% of his tuition costs, then only 25% of the Whitworth sponsored financial aid will be applied to the account, since the student is being charged 25% of the full tuition. If much of your tuition costs were covered by financial aid, then much of your refund will be returned to these financial aid programs.
- If you have received federal or state financial aid in the form of cash, to assist you with *non-institutional charges*, you **may need to repay immediately the grant funds that you received** or make satisfactory payment arrangements. This may include:
 

Federal Pell Grant	State Need Grant
Federal SEOG	TEACH Grant

 Loans received as cash to assist with non-institutional charges and work-study are not required to be returned. Loans are repaid as specified on the promissory note and therefore do not need to be paid back immediately.
- Return of Funds Example:**

Josephine Example begins study at Whitworth for the first time. On the first day of the third week of classes she has a bad bout of homesickness and withdraws. She has been living on campus so her charges for the semester are:

Tuition \$22,525	Fees \$600	Room & Board \$6,075

She has received on her account the following aid:

Federal Pell Grant \$2,000	Federal Direct Subsidized Loan \$1,732	Whitworth Grant \$5,000
Federal SEOG \$ 500	Federal Direct Unsubsidized Loan \$990	

And earned \$150 on Federal Work-Study, which was paid by payroll check.

She paid \$1000 onto her account out of her own money and planned to pay the balance during the semester.

The return of financial aid funds to the federal government and Whitworth is as follows:

Federal Direct Subsidized Loan \$1,732	Federal Direct Unsubsidized Loan \$990
Federal Pell Grant \$1,685.37	
Whitworth Grant \$3,750 (75% of \$5000, because of 75% tuition refund)

The charges after the refund would be:

## STEP 2: Percentage of Title IV Aid Earned

A school that is not required to take attendance may, for a student who withdraws without notification, enter 50% in Box H and proceed to Step 3. Or, the school may enter the last date of attendance at an academically related activity for the "withdrawal date," and proceed with the calculation as instructed. For a student who officially withdraws, enter the withdrawal date.

**H. Percentage of payment period or period of enrollment completed**  
Divide the calendar days completed in the period by the total calendar days in the period (excluding scheduled breaks of five days or more **AND** days that the student was on an approved leave of absence).

- ▶ If this percentage is greater than 60%, enter 100% in Box H and proceed to Step 3.
- ▶ If this percentage is less than or equal to 60%, enter that percentage in Box H, and proceed to Step 3.

## STEP 3: Amount of Title IV Aid Earned by the Student

Multiply the percentage of Title IV aid earned (Box H) by the Total Title IV aid disbursed and that could have been disbursed for the period (Box G).

## STEP 4: Title IV Aid to be Disbursed or Returned

- ▶ If the amount in Box I is greater than the amount in Box E, go to Post-withdrawal disbursement (Item J).
- ▶ If the amount in Box I is less than the amount in Box E, go to Title IV aid to be returned (Item K).
- ▶ If the amounts in Box I and Box E are equal, **STOP**. No further action is necessary.

### J. Post-withdrawal disbursement

From the Amount of Title IV aid earned by the student (Box I) subtract the Total Title IV aid disbursed for the period (Box E). This is the amount of the post-withdrawal disbursement.  
**Stop here**, and enter the amount in Box 1 on Page 3 (Post-withdrawal disbursement tracking sheet).

**STEP 6: Return of Funds by the School**

**STEP 7: Initial Amount of Unearned Title IV Aid Due from the Student**

From the amount of Title IV aid to be returned (Box K) subtract the Amount for the school to return (Box O).

**STEP 8: Repayment of the Student's loans**

From the Net loans disbursed to the student (Box B) subtract the Total loans the school must return (Box P) to find the amount of Title IV loans the student is still responsible for repaying (Box R).

These outstanding loans consist either of loan funds the student has earned, or unearned loan funds that the school is not responsible for repaying, or both; and they are repaid to the loan holders according to the terms of the borrower's promissory note.

▶ *If Box Q is less than or equal to Box R, STOP. The only action a school must take is to notify the holders of the loans of the student's withdrawal date.*

**STEP 9: Grant Funds to be Returned**

▶ *If Box U is less than or equal to zero, STOP. If not, go to Step 10.*

**STEP 10: Return of Grant Funds by the Student**

Except as noted below, the student must return the unearned grant funds for which he or she is responsible (Box U). The grant funds returned by the student are applied to the following sources in the order indicated, up to the total amount disbursed from that grant program minus any grant funds the school is responsible for returning to that program in Step 6.

**Note that the student is not responsible for returning funds to any program to which the student owes \$50.00 or less.**

## **Summary of the Federal Requirements for the Treatment of Title IV Aid When a Student Withdraws (34 CFR 668.22)**

The law specifies how your school must determine the amount of Title IV program assistance that you earn if you withdraw from school. The Title IV programs that are covered by this law are: Federal Pell Grants, Iraq and Afghanistan Service Grants, TEACH Grants, Direct Loans, Direct PLUS Loans, Federal Supplemental Educational Opportunity Grants (FSEOGs), and Federal Perkins Loans.

Though your aid is posted to your account at the start of each period, you earn the funds as you complete the period. If you withdraw during your payment period or period of enrollment (your school can define these for you and tell you which one applies), the amount of Title IV program assistance that you have earned up to that point is determined by a specific formula. If you received (or your school or parent received on your behalf) less assistance than the amount that you earned, you may be able to receive those additional funds. If you received more assistance than you earned, the excess funds must be returned by the school and/or you.

The amount of assistance that you have earned is determined on a pro rata basis. For example, if you completed 30% of your payment period or period of enrollment, you earn 30% of the assistance you were originally scheduled to receive. Once you have completed more than 60% of the payment period or period of enrollment, you earn all the assistance that you were scheduled to receive for that period.

If you did not receive all of the funds that you earned, you may be due a post-withdrawal disbursement. If your post-withdrawal disbursement includes loan funds, your school must get your permission before it can disburse them. You may choose to decline some or all of the loan funds so that you don't incur additional debt. Your school may automatically use all or a portion of your post-withdrawal disbursement of grant funds for tuition, fees, and room and board charges (as contracted with the school). The school needs your permission to use the post-withdrawal grant disbursement for all other school charges. If you do not give your permission (some schools ask for this when you enroll), you will be offered the funds. However, it may be in your best interest to allow the school to keep the funds to reduce your debt at the school.

There may be some Title IV funds that you were scheduled to receive that cannot be disbursed to you once you withdraw because of other eligibility requirements.

If you receive (or your school or parent receives on your behalf) excess Title IV program funds that must be returned, your school must return a portion of the excess equal to the lesser of:

1. your institutional charges multiplied by the unearned percentage of your funds, or
2. the entire amount of excess funds.

The school must return this amount even if it didn't keep this amount of your Title IV program funds. If your school is not required to return all of the excess funds, you must return the remaining amount.

For any loan funds that you must return, you (or your parent for a Direct PLUS Loan) repay in accordance with the terms of the promissory note. That is, you make scheduled payments to the holder of the loan over a period of time.

Any amount of unearned grant funds that you must return is called an overpayment. The maximum amount of a grant overpayment that you must repay is half of the grant funds you received or were scheduled to receive. You do not have to repay a grant overpayment if the original amount of the overpayment is \$50 or less. You must make arrangements with your school or the Department of Education to return the unearned grant funds.

The requirements for Title IV program funds when you withdraw are separate from any refund policy that your school may have. Therefore, you may still owe funds to the school to cover unpaid institutional charges. Your school may also charge you for any Title IV program funds that the school was required to return. If you don't already know your school's refund policy, you should ask your school for a copy. Your school can also provide you with the requirements and procedures for officially withdrawing from school.
